CONDITIONS

1. Registration Fee

The registration fee is valid for a one-year period from September to the end of August, and is **non refundable**. Students are only allowed to attend one class before they pay the registration fee. Students may not purchase a series of classes (10 or 20) before having paid the registration fee. All students must pay the registration fee.

2. Ballet Classes, ballet technique, jazz-modern, modern contemporary and lyrical jazz classes:

A minimum of three (3) people is needed to open a class. With only three (3) people, the class will last one hour. For four (4) people and over, the class will be its regular hour and a half.

3. Pointe Class:

A minimum of four (4) people is needed to open a pointes class. The payment for the class must be done before class.

4. Refund – Classes by Session:

In accordance with Consumers' Law, withdrawal from a session course must be made in writing during the first thirty days of the session. We will reimburse the balance for the classes **that remain** minus a 10% administration fee (\$50 maximum) *Article 195 of the Consumer Protection Act R.S.Q., chapter P-40.1.*

When a withdrawal is made after the first thirty days of the session, we will issue a refund only upon presentation of medical documentation.

5. Refund – Series of Classes:

We will issue a refund in part or in full for a series of classes (10 or 20) only upon presentation of medical documentation. Classes already taken will be charged at the regular rate of \$19.00 and we will reimburse the remaining amount minus a 10% administration fee (\$50 maximum) *Article 195 of the Consumer Protection Act R.S.Q., chapter P-40.1.* in the two weeks following the reception of a written notice.

At the end of the three-month validity of a series of classes (10 or 20), the value of the remaining classes is **non refundable**. However, we can come to an agreement with a student who intends to keep on taking classes at Ballet Divertimento.

6. Professional Rate:

The professional rate is offered to RQD members registered as professional dancer or teacher status, to the members of ACTRA, UDA and to the employees of professional dance companies. It is also offered to students who participate to a dance-study program of a renowned dance school. Any question should be addressed to the General Director of Ballet Divertimento. In all cases, you will have to present a proof.

7. Lost Items:

Ballet Divertimento is not responsible for lost or stolen items. As a safety precaution, students should be vigilant and bring their valuables with them to the studios.

8. For those students who register late for a course given by session, the classes not taken will be deducted from the tuition fee with the exception of the first two weeks of classes which are not refundable.
